- Prasarana Malaysia Berhad (“Prasarana”) is a fully Government-owned company established to facilitate, undertake and expedite public infrastructure projects approved by the Government. Prasarana and its group of companies are the asset owners of Ampang, Sri Petaling and Kelana Jaya LRT lines, KL Monorail, Bus operations and operator of Mass Rapid Transit (“MRT”) Sungai Buloh-Kajang (“SBK”) Line.
- The Government of Malaysia has appointed Prasarana to form and be part of the RTS Operations Pte Ltd (**EMPLOYER**). RTS Operations Pte Ltd means the entity formed by the Malaysia JV Shareholder, Prasarana Malaysia Berhad and the Republic of Singapore JV Shareholder, SMRT Corporation Ltd.
- The Government of Malaysia and Government of the Republic of Singapore have agreed to jointly develop approximately 4.6 kilometers cross-border Rapid Transit System that would connect Woodlands, Republic Singapore and Johor Bahru, Malaysia crossing the Straits of Johor. RTS Link project to enhance connectivity between Malaysia and Republic of Singapore, to benefit commuters who travel between Republic of Singapore and Johor Bahru.
- Prasarana has been appointed by RTS Operations Pte Ltd as its representative to undertake and manage this tender exercise until the submission of the Tender by the Tenderer. All evaluations and assessments will be carried out by RTS Operations Pte Ltd of which Prasarana has no role to play.
